## Purcari Winery installs a Photovoltaic System

Bucharest, 3<sup>rd</sup> of August 2022

Following its broader ESG agenda, Purcari Wineries PLC ("The Group") is proud to announce the installation of a Photovoltaic System, on the rooftop of Purcari Winery's production site.

The Solar Panel System covers an area of  $1,025~\text{m}^2$  and allows to produce 240.000 kWh of energy per year. The newly installed system will supply 15% of the Purcari winery's electricity consumption, which brings the Group closer to its ambition of a more sustainable and  $CO_2$  neutral production.

The Group will continue to increase its investments in sustainability and follows the objective of attaining the coverage of up to 80% of its energy demand from photovoltaic power stations.

"We remain committed to achieving the long-term goal of environmental sustainability in our activity, and the investment in a Solar Panel System is a certain sign of our allegiance in doing so.
