Correction to the Notification of Major Holdings

Purcari Wineries Public Company Limited (hereinafter referred to as the “Issuer”) was notified on 02.11.2022 by East Capital Asset Management SA (hereinafter referred to as the “Shareholder”) regarding the Corrections to its Disclosure Notice of stake decrease under the 5% threshold, published on the 19th of October.


The Corrections made within the Disclosure Notice are as follows:

- Page 1, field 3, “Details of person subject to the notification obligation”: change from the name of the beneficial owner to the name of the Shareholder – East Capital Asset Management SA.
- Page 1, field 7, “Total number of voting rights of issuer”: change from the number of shares which crosses the threshold of the Shareholder, to the total number of voting rights of the Issuer – 40,117,500.
- Page 2, field 7, “Position of previous notification (if applicable)”: completion with the previous stake position of the Shareholder – 5.86%.

The above-mentioned corrections do not contain changes in the number of shares decreased that was announced on the 19th of October 2022.

Therefore, as of 18.10.2022, East Capital Asset Management SA reduced its stake to 1,985,048 - 4.96% in share capital.


